STATEMENT OF OPERATIONS

The use of this affidavit is a privilege. It may be withdrawn at any time, for any reason deemed appropriate. This privilege is extended with the understanding that returns are an accurate account of full copies returned from college readership distribution locations only. All copies must be properly marked, painted, and disposed of so as to preclude their resale or re-entry into any other return system. Returns are for one week period only, Monday thru Friday, so that the returns contain copies for that period exclusively. An affidavit and "in and out sheets" must be sent weekly and only one affidavit is accepted for a given week per week per participating college program. Returns more than three weeks older than the issue date will not be accepted. You must maintain detailed records indicating by drop location the number of copies each day and the number of remaining copies picked up the following morning. You must keep these records summarized by week for no less than a six month period so that they can be audited and reconciled to the credits granted to you.
